The meeting will be held at Pierce County Board of Commissioners' Office and will be opened to the public. Proposals can be mailed or delivered to the attention of Jason Rubenbauer, County Administrator for the Pierce County Board of Commissioners, P.O Box 679, 312 Nichols Street, Suite 5, Blackshear, Georgia 31516. Proposals received after the designated time will not be considered. Pierce County Board of Commissioners may select a successful low bidder after evaluation of all bids.

The Scope of Work Includes: Striping Improvements to Various County Road (103.71 Miles)

All proposals shall be accompanied by a Bid Bond in favor of the **Pierce County Board of Commissioners** in the amount of at least five percent (5%) of the lump sum bid for the complete work: such Bid Bond representing that the Bidder, if awarded a Contract, will promptly enter into a Contract and furnish Performance Bond and Payment Bonds as provided by the law and approved by the Attorney for the **Pierce County Board of Commissioners**. Performance Bond shall be equal to 100 Percent (100%) of the contract amount and Payment Bond shall be equal to 100 percent (100%) of the Contract amount.

The Bid Bond shall be forfeited to the <u>Pierce County Board of Commissioners</u> as liquidated damages if the Bidder fails to execute the Contract and provide Performance and Payment Bonds within (10) days after being notified that he has been awarded the Contract.

All work on the project must be completed within 120 consecutive calendar days of the notice to proceed.

The Contractor shall be a current "Prequalified Contractor" with the Georgia Department of Transportation, Office of Contract Administration or shall be approved in writing by the Pierce County Board of Commissioners prior to bids being opened. A copy of the Contractor's "Notice of Contractor Qualification" as issued by the Georgia Department of Transportation or a copy of an approval letter from the Coffee County Board of Commissioners must be submitted with the bid.

The Georgia Department of Transportation Standard Specifications, 2021 Edition, any applicable Supplemental Specifications, or Special Provisions, contained within this contract will be applicable to this project. All materials, workmanship, testing, etc. shall meet the Georgia Department of Transportation Specifications.

The Owner reserves the right to reject all bids and to waive informalities, and to accept any Bid which in its opinion may be in the best interest of the Owner. The Owner has the right to add or to delete from the Contract once it has been awarded. No bids shall be withdrawn for a period of 60 days after the opening of the bids.
