- 1. Call to Order-Chairman Bennett called the Regular Meeting to order at 6:00 PM.
- 2. Invocation and Pledge of Allegiance Commissioner David Lowman gave the invocation, and Commissioner Harold Rozier led the Pledge of Allegiance.
- 3. Approval of the Agenda

Commissioner Randy Dixon made a motion to approve the agenda as presented. Commissioner David Lowman seconded the motion. There was no discussion. All commissioners voted aye. Motion was unanimously approved.

Commissioner Randy Dixon made a motion to accept the approve

5:00 PM Public Hearing Minutes, and the October 4, 2022 6:00 PM Regular Meeting Minutes as presented. Commissioner David Lowman seconded the motion. All commissioners voted aye. Motion was unanimously approved.

5 Public Comments:

a. Ala Mae Myles wishes to address the Commission regarding the repair of her driveway and installation of crush and run and trimming of overhanging limbs.

Ms. Myles presented request to the Commission that the road leading to her residence be designated a county road, and have the county install crush and run and trim overhanging limbs. Ms. Myles asserts that in years past the county has maintained this road, and she is unable to do so herself due to age and health issues. Chairman Bennett advised Ms. Myles that this subject has been discussed at previous meetings, and as before that the county's position is this a private road, and no work such as what is being requested is allowed, furthermore the county has no interest in incorporating this as a county road. Request declined by Chairman Bennett.

b. Bill Rozier, Chief Appraiser wishes to have a member of Georgia Mass Appraisal Solutions (GMASS) to address the Commission regarding the revaluation process for Pierce County.

Bill Rozier introduced Silas Hrober, Project Manager for GMASS, who gave a presentation regarding the ongoing property appraisal and revaluation process for Pierce County. Mr. Hrober advised that currently GMASS has 10 Field Appraisers working in Pierce County, with 375 parcels left to be inspected. Beginning January 1 of 2023 appraisers will begin reevaluating properties under construction, and in April sales will be evaluated. The next step in the process will be data analysis and setting schedules; 6 appraisers are currently working on this. Mr. Hrober reminded that the reason GMASS is being tasked with this evaluation is that it is statutorily and constitutionally required to assess properties at fair market

value. Mr. Hrober estimates a 15 percent net increase in values after completion of this survey.

c. Chief Santo Nino, Fire Chief/EMA Director wishes to address the Commission regarding the reclassification of Deputy Fire Chief/EMA to Fire Operations Captain.

Chief Nino presented the need to fill the recently vacated Deputy
Fire Chief/Deputy EMA Director position, and also stated the desire
to reclassify the position to be a Fire Administration Operations
Captain. Chief Nino stated that it is critical this position be filled
due to him currently being the only full-time member on staff in the
face of increasing call volumes, and someone is needed to augment
operational response after hours and on weekends. Commissioner
David Lowman pointed out that a decision would need to be made
as to whether the reclassified position would be an exempt or nonexempt position. Chairman Bennett proposed that the matter be
further researched in regards to pay and other criteria.
Commissioner Lowman suggested that action be taken to advertise
the position and gather a pool of applicants, which Chairman
Bennett consented to.
