1. Call to Order – Chairman Bennett called the meeting to order at 6:00 PM

2. Invocation and Pledge of Allegiance – Commissioner David Lowman gave an invocation and Commissioner Mike Streat led the pledge of allegiance.

3. Approval of the Agenda

<u>Commissioner David Lowman made a motion to approve the agenda.</u>

<u>Commissioner Harold Rozier seconded the motion. All voted aye and motion was approved.</u>

4. Approval of Minutes

a. Regular Meeting Minutes, July 7, 2020

Commissioner Harold Rozier made a motion to approve the minutes from the July 7, 2020 regular meeting. Commissioner David Lowman seconded the motion. All voted aye and motion was approved.

5. Request from Wade Grant to speak about bad dogs. – Wade Grant of 1936 Hacklebarney Lane, Blackshear stated that there is a house on the corner that has 2 pit bulls and they hem him up in the road when he rides his motorcycle. There have been multiple situations where he has had to stop his motorcycle to avoid an accident and even an incident when he was in his pickup truck. He has asked the people to keep the dogs contained but its not happening. He has contacted the Sheriff Office and nothing has been done. He doesn't want to harm the dogs, just wants to be able to ride his motorcycle without the dogs causing a problem. The road is very sandy so you have to drive slow especially on the motorcycle. He would just like to the see the people keep the dogs contained.

 - ii. Registration for Fall sports is still ongoing and late fees have been waived
 - iii. GRPA is meeting next week to discuss state and district play, even though there may not be state or district competitions our Recreation Coordinator is working with surrounding counties to see what we can do to still provide competitive sports to those who wish to participate even though the season may be later that normal which is dependent on the numbers and final GRPA decision. Currently registration numbers are extremely low
- c. Fire/EMA/Public Safety
 - Southside and Bearville Fire Stations have passed final inspection and have now been put into active status in the new buildings as of Monday, August 3rd
- d. Elections
 - Early voting for the Sheriff's run-off and the Democratic US Congress runoff has seen greater than expected numbers. Lowest count for a day 89 – high was 196
 - 1. 699 Absentee ballots have been received
 - 2. 1638 in person ballots have been cast
 - 3. Final day to vote for both is Tuesday, August 11th

7. Request to approve Grant Resolution for Community Facilities Grant from USDA for a Fire Truck. Grant amount of \$21,000.00 and County Contribution will be \$39,000.00. Chairman Bennett noted that Karen Jameson with the USDA is attending the meeting by phone.

Commissioner Randy Dixon made a motion to approve the resolution for the Community Facilities Grant from USDA for the fire truck in the amount of \$21,000 with a county contribution of \$39,000. Commissioner David Lowman seconded the motion. All voted aye and motion was approved.

8. Request from Pierce County Library Board for appointment of Laci Gillis to fill the remainder of a term vacated by Dan Bennett that will be effective immediately through December 31, 2021.

Commissioner Randy Dixon made a motion to appoint Laci Gillis to the Pierce
County Library Board for a term that begins immediately and ends December 31,
2021. Commissioner Harold Rozier seconded the motion. All voted aye and motion
was approved.

9. Request to allocate matching funds to cover \$39,000 from the 2020 SPLOST and the General Fund as appropriate for the purchase of a fire engine in the amount of \$60,000. (This will be bid once the grant is awarded)

Commissioner Randy Dixon made a motion to approve the funding of the county portion of the fire truck from the 2020 SPLOST or General Fund as appropriate.

Commissioner David Lowman seconded the motion. All voted aye and motion was approved.

10. Request to allocate available 2014 SPLOST Funds (\$31,481.41) and
Transportation Investment Act Discretionary funds for the purchase or lease of a
Dump Truck (14-16 yd capacity) using state contracting prices or better. To be
paid from the 14 SPLOST. Estimated cost \$150,000 — County Manager Jason
Rubenbauer stated that he is looking heavily into lease option because the miles
that we would put on the truck will be low and we should get a good buy back
price. Commissioner Dixon stated that he would definitely like to see us look at
lease option because we can eliminate the repair costs and maintain a quality
truck at all times. He would like to see us with a 24 month lease, that would be in
the county best interest.

Commissioner Randy Dixon made a motion to move forward in the purchase/lease of a dump truck at state contract pricing and to pay \$31,481.41 from the 14SPLOST and the remainder from the TIA discretionary funds. Commissioner Harold Rozier seconded the motion. All voted aye and motion was approved.

11. Request to replace the fencing around Moose Jowers field using **2014 SPLOST** funds. Chairman Bennett explained that there were 2 proposals received. Thrift Contractors submitted a proposal for \$4800.00 with a 9 gauge fence – not coated and T & T Fencing submitted a proposal for \$5200.00 for the same fencing.

Commissioner Randy Dixon made a motion to approve the low proposal from Thrift Contractors of \$4800.00. Commissioner Harold Rozier seconded the motion.

All voted aye and motion was approved.

12. Request to seek bids for inventory and complete assessment of all countyowned paved roads in Pierce County for the purpose of establishing a
comprehensive project list using Transportation Investment Act Discretionary
funds. Chairman Bennett explained that this will be an evaluation of the condition
of all the roads in the county that will help us prioritize paving. Commissioner
Rozier asked if this evaluation will also look at water run-off. Chairman Bennett

asked the County Manager to make sure that the RFP is clear in requesting that be considered and noted in the evaluation process.

Commissioner David Lowman made a motion to move forward with seeking proposals for Inventory and complete assessment of the county-owned roads in Pierce county to include water run-off in the assessment. Commissioner Randy Dixon seconded the motion. All voted aye and motion was approved.

13. Request to approved the final stumping and piling of debris at the recreation department to be paid for with **2014 SPLOST funds.** Chairman Bennett stated that we received two proposals for the project. Proposal from DB Wells was for \$4,750.00 and from Richard Blythe for \$8000.00

Commissioner Randy Dixon made a motion to approve the proposal from DB Wells at \$4,750.00 to complete final stumping and piling of debris at the Youmans St recreation property. Commissioner Harold Rozier seconded the motion. All voted aye and motion was approved.
