- 1. Call to Order—Chairman Bennett called the meeting to order at 6:00 PM
- 2. **Invocation and Pledge of Allegiance**—Commissioner Mike Streat gave the invocation and Commissioner Randy Dixon led the Pledge of Allegiance

- 4. Approval of Minutes
 - a. Public Hearing and Regular Meeting Minutes, July 5, 2022

Commission Randy Dixon made a motion to approve the July 5, 2022 Regular Meeting Minutes. Commissioner David Lowman seconded the motion. All Commissioners voted aye. Motion was unanimously approved.

- 5. Public Comments
 - a. Johnny Thigpen would like to offer a proposal to establish a Parks & Recreation Board or Advisory Committee

Mr. Thigpen presented a request to establish a Recreation Board that would report directly to the Board of Commissioners. It was recommended that a member of the Board of Commissioners serve on the Recreation Board as a liaison and that the County Manager would have no part in the recruitment, hiring, or management of the Recreation Director or any employees or operations of the Recreation Department.

Commissioner David Lowman made a motion to enact a Recreation Board that reports directly to the Board of Commissioners and would have one member of the Board of Commissioners to sit on the Recreation Board as a liaison. Commissioner Randy Dixon seconded the motion. All Commissioners voted aye. Motion was unanimously approved.

6. County Manager Report and June 2022 Financials—County Manager, Jason Rubenbauer, presented the following June 2022 Financials

- a. Current General Fund revenues are consistent with projections through June 2022
- b. EMS collections continue to increase
- c. SPLOST Revenues for June are 11% higher than last year while July SPLOST Revenues are up approximately 19% over last year
 - i. Transfers to reimburse the General Fund from the SPLOST fund for the jail addition are being processed and will continue until the previously approved amount has been fully collected
 - ii. Current collection rates from the SPLOST should allow for full collection of the jail addition expenses by January 2026 as anticipated. This allowed for you to fund this project without creating any financing or other means of debt service
- d. Expenditures overall remain in line as projected.

e. Departmental updates:

- i. <u>EMS</u>
 - 1. 275 medical responses for service in July
- ii. <u>Fire</u>
 - 1. 389 calls for 2022 with 6 calls for service this past weekend alone
 - 2. Effective August 1st, the new ISO rating of 5/5X has taken effect. Citizens are reminded to reach out to their homeowners insurance companies to see what savings may be available to them as a result of the improvements of our countywide rating
- iii. Planning & Codes
 - 1. Four (4) new homes permits were issued in July bringing the total new homes for 2022 to 40
 - a. This is eight (8) more than last year

- iv. Roads
 - 1. Big House Road pipe installation have been completed
 - 2. Crews are now focusing on:
 - a. Crump Road
 - b. Holland Road
 - c. Mill Branch
 - d. Meadow Wood Loop (delayed locate service due to utilities not able to find some of the wires listed)
